(150 Words) (10 Marks)

Ans- Kant is a deonto logist and focuses on whether one does his duty well or not, lest other determinants like character of the agent and consequence of the act doesn't matter.

Kant also gave categorical imperatives to judge if an action is moral or not

i.e -

(a) Do unto others what you want them to do unto you.

Act according to maxims that can be turned into universal laws.

(b) Don't use man as a means to an end, but an end in itself.

(c) Do what is good for the society as a whole.

Kant emphasised that duty is all that matters and one ought to perform his/her duty aptly to ensure

that all goes well within the society.

Kant has been criticized on the following points -

- (1) He emphasizes too much on absolute duty and is opposed by Prima Facie Duty theory by W.D. Ross.
- (2) Society works on using man as a means to achieve goals, so such a C.I. may not be pragmatic (c)
- (3) He is criticized for being too metaphysical instead of being pragmatic.

But, Kant's categorical imperatives are valid even in the present times and holds a key in moral education.

Q4. Why does cultural relativism supposedly make us more tolerant of other cultures and, critically examine the view that moral values are relative? (150 Words) (10 Marks)

~~cultural Relativism makes the claim that what is ethical and what isn't depends on the culture and different cultures may perceive the same deed as both a virtue and a vice.~~

~~This conveys that moral values are relative and what may be wrong for one, may not be the same for others. This makes a person more tolerant of others' cultures as good and bad, right and wrong are not case dependent but depends on what the culture perceives.~~

~~Though Moral values are relative and may change with time, space and culture they lie on some basic tenets. For ex - In some cultures elders are killed to ensure they remain active and young in afterlife. But this is based on the basic tenet of valuing and respecting our elders. So, while some tenets are culture dependant~~

~~Remarks others are universal.

Also, if cultural relativism is too much relied upon, social change won't ever be possible and even practices like sati, polygamy, slavery would have still been prevalent.

Thus, while some values may be relative but some basic and humanitarian values are universal. One needs to find a "Golden Mean" between Relativism and Universalism of values i.e. ethical Pluralism, which proounds more than one solution to problems.

Q5. What is moral crisis? Cite some examples from Indian society and polity. Explain the statement in right context- "The hottest places in hell are reserved for those who, in times of great moral crisis, maintain their neutrality." (150 Words) (10 Marks)

Ans Moral crisis occurs when one has to choose b/w personal welfare and public welfare. They occur when people try choosing between what the society wants from them & what they want to do.

In Indian society, a husband might find himself in a moral crisis while both choosing who is right - his mother or his wife. In politics, a minister may not be willing to support a bill out of its sheer complexities, but that would mean going against party whips.

But what makes the difference is what a person chooses when s/he encounters such a situation. While a person may have a negative attitude towards dowry, he may act the other way round.

Remarks

Those who don't take a decision during moral crisis are bound to hell as they are defying their critical thinking capabilities and allowing emotions to take precedence over their objectivity.

for example - If Raja Ramnath Roy wouldn't have taken a call, sati would still have been prevalent

Thus, moral precepts need to be coupled with in real life situations and one ought to take a stand for bringing about change in society

- Q6. It is commonly accepted that: "don't promise when you are happy, don't answer when you are angry, and don't decide when you are sad". What is the essence of this statement for a working civil servant?

(150 Words) (10 Marks)

Ans The statement is a clear reflection of not taking certain steps when one is in "neutral" phase. One needs to learn to live with one's emotions and objectively decide what to do during certain phases of emotional outburst.

for a civil servant, the statement is of immense importance, for s/he has to control her/his emotions while also perform her/his duty.

For Ex - If one is angry, s/he may respond in an adverse way and cause ruckus within the system. Thus not answering while being angry would help one to remain in an amicable situation.

Remarks

Suppose, one promises a grandiose scheme while being happy, but may not have the adequate resources to fulfil it and realises <sup>his</sup> only after critical thinking, is bound to create false promises.

Decision making involves a healthy state of mind. Sadness even prompts people to take extreme steps like suicide, which is the perfect example of ineffective decision making that arises out of disbalanced emotions.

Thus, the statement rightly adjudges to take prequalified decisions to be able to fulfil the same.

~~Aristotle was a virtue ethicist and continued with "Ethics of Happiness" as given by Socrates and Plato. He also propounded the theory of "Golden Mean" wherein extremes need to be avoided.~~

~~Aristotle suggested that this mean may not be exactly at the centre, but may vary as per situations. His theory is similar to Buddha's theory of Middle Path, though with different objectives.~~

~~He propounded that between cowardice and maledictiveness, courage should be chosen as the golden mean and the following will help assist the golden mean to the people-~~

- (a) Experience
- (b) Logic
- (c) Self-deduction.

Remarks

But, it may not always be easy to acknowledge the middle of extremes. situational constraints may force a person to choose otherwise.

The doctrine is relevant for a working civil servant as it helps her/him to choose wisely and not take extreme actions or decisions in a fit of rage. It also helps to inculcate a value of working & living on a decent scale & not involving in unethical acts. not involving in unethical acts.

Ans. Doctrine of Double Effect implies that an action may have an intended positive ~~harm~~ effect and simultaneously an unintended harm which may or may not be foreseen. For ex- While treating complexities developed in a pregnant woman, a doctor may save the woman, but might not save the child. But, she didn't wish to do that, but it did have a double effect.

"Principle of Permissible Harm" states that while an action may do a considerable amount of good, it might cause some harm which wasn't intended but could be foreseen. Ex- In case of Euthanasia, while trying to ease out the pain of the patient, the doctor may be actually killing the patient.

Remarks

In Real life, usually such dilemmas occur, where one has to weigh the benefits and problems arising out of a complex situations and it is here where "Principle of Permissible Harm" holds significance.

Thus, moral laws allow "Principle of Permissible harm" as all situations in real life are not a Yes/No type situation and one has to outweigh positives with negatives to arrive at a situation.

~~The objective of one's action here is to change the work culture and also the mindset of the employees who find it just to demand money for work that is part of their job.~~

~~After checking the veracity of the claims, the following options are available -~~

(a) Orientation program - An orientation program for the employees that involves allegory method with visual aids to strike the moral chord of the employees. As Socrates said - Man doesn't knowingly err, but errs due to lack of knowledge. If employees are made aware of their wrongdoings, they are bound to mend their ways.

Remarks

- (b) Reward and Punishment Mechanism - can be devised to give incentives to employees for being corruption free. This will motivate them for being true to their duties.
- (c) Awareness among citizens - A board outside the office, that no money needs to be given for availing services needs to be put up. A helpline number in case of dereliction of duty can be also provided.
- (d) informal talks and formal deliberations - One needs to set a precedent for a right work culture by getting involved and asking the employees on personal & professional levels to be true to oneself.
- (e) Not taking any action and assuming change will come by itself would be the wrong thing to do. Professional advice talks of taking steps to improve

work culture and that will have to be done.

Thus, except for (e), all others (a to d) will have to be taken up to ensure some qualitative change in work culture of the organisation. A holistic strategy of both short term and long term measures needs to be devised to ensure a change in attitudes.

Response is not very encouraging, however, a prominent local politician with a criminal record offers a hefty donation. The options available are:

- Take donation from that politician.
- Reject offer of that politician as his track record is poor.
- Ask him to directly assist to those who are in need.
- Reduce your operational scale to affordable level, so that you can sustain charitable work.

Analyse each option with its consequences.

Ans:

The dilemma here is to whether look at this problem from a deontological perspective or from a teleological perspective. If means are taken as ends, taking money from a criminal would be a vice. If ends are considered, helping the poor is a virtue. Let's analyse the available options -

- Taking donation from the politician may make monetary crisis disappear but this would bring wrong precedent for the society. Also, s/he may be donating for electoral reasons.

Remarks

- (b) Although this may direct his wrath on me, but morality doesn't allow me to take donations from someone who isn't ~~worthy~~ enough.
- (c) While asking him to directly assist may still be used by him for electoral gains, but may be s/he is experiencing a change of heart and wants to give back to the society.  
 One may recommend it to <sup>him</sup>  
her to contribute directly, but the final decision will be his/her.
- (d) Until funds aren't available, this would be the best option to follow or else the elder of this marginal community can be roped in to make traditional items and sell them for a considerable price.

But the local residents are not happy with the management of the company and big group of local residents are protesting continuously. Your father is a senior IAS officer placed in the concerned Ministry. He is influential and very well networked. Company's management is pushing you to manage the situation and local authority through your father, as putting high quality production facility in plant will increase the cost of production, and company may lose market share in terms of sales if cost goes high. Based on the above situation answer the following questions:

- (a) What are the options available to you?
- (b) Discuss merits & demerits of each option.
- (c) What will be your final call? Justify.

(250 Words) (20 Marks)

Ans. The situation depicts a conflict between personal gain and moral values. The following options are available-

- ① Giving in to the demands of the company. This isn't the right thing to do, as this would create wrong precedent and dereliction of duty by my father.
- ② Dodging the calls of the company staff to give them a hint that economy won't outrun labor requirement.

Remarks

① ~~informing my father about the company influencing me so that he may take strict action against them.~~

My final call would be to take a combination of ② + ③ & ④ ⑤ set the right precedent and also to be able to protect local water sources to be contaminated.
