Patent of vaccines when the world is suffering from pandemic raises following ethical issues:

With an agreed compensation Patent waivers could be granted. We must remember "No one is safe until all are safe".



Media is the guardian of democracy.  
It makes an essential feedback loop  
between the citizens and the government.

Impartial and objective reporting

is one of the hallmarks of robust media,  
However, a decline has been witnessed  
in recent times.  
eg Mumbai police busted a fake TRP  
newspaper recently.

#### Reasons for Decline

- ① Race of catching maximum eyeball.
- ② TRP determining the success of report.
- ③ Increased competition.
- ④ Corrupt practices like paid news, agenda setting.
- ⑤ Drafts by self regulatory mechanism  
to check unethical reporting.

Remarks

Ethics in media has been on decline  
 but it is definitely not a thing  
of past. Media has played key role  
 in ensuring accountability and  
transparency in governance

e.g. During the second wave of Covid <sup>highlight some ethical issues with burying</sup>  
media reporting about lack of oxygen, media such as  
beds helped thousands by ensuring media trials etc.  
 that SOS messages reach authorities ✓

The independence of media needs to be balanced with ethics in order to ensure that it plays the role of creating check on authorities and raising cause of vulnerable sections.

Strengthening of self regulatory mechanism, stricter penalties in case of violation of guidelines is the way forward.

4. "Imposition of high sin tax by the government instead of outright ban on harmful products for consumption by the people shows their moral bankruptcy evolved out of capitalism".  
 Comment. (150 Words) (10 Marks)

Sin tax is a tax applied on the over and above normal taxes on the goods declared as sin goods. e.g. Alcohol, Tobacco

The nationale of sin good instead of ban is as follows

- ① discourages usage of sin good but allows a individual discretion.
- ② Bans may lead to black market
- ③ Protects the employment of people engaged in the production of sin goods
- ④ Provides additional funds to government specially state government to finance its welfare scheme.

The arguments in favour of ban can be :-

- ① Harmful product use can be justified at any cost.
- ② Social impact is undefined due to

economic impact

e.g. women are the greatest sufferers on account of alcohol addiction.

- ③ only complete ban is useful in order to eliminate harmful products from society.

Administratively implementing sin tax is not easier and effective vs a yes/no outright ban. The evidences from states like Bihar show that a ban on alcohol products has led to black market.

In the fight against intoxicants and other harmful products while ban is desirable but sin tax is more pragmatic in nature.

Analyze the utility of sin tax like does it actually discourage consumption or not etc?

5. 'A coward is incapable of being ethical, it is the prerogative of the brave'. Comment.

Ethics are the principles applied to establish 'good' or 'bad'. Being ethical involves practising ethical conduct in every circumstance.

The practise of ethics is not an easy task. Several hurdles like external pressure, desires, conflicting values are present in real life.

Only courageous person is capable of being ethical because in order to resist such hurdle 'courage' is key.

e.g. A policeman may preach honesty to all but when given a chance for self enrichment, if he is a coward and cannot stand by his principle then he may compromise.

Courage ensures integrity in conduct: Standing by the values and

principles even in the face of adversity is the hallmark to a ethical person.

IAS Ashok Khemka who unearthed several scams in Haryana has been transferred about 40 times in his 23 years of career but he remain undeterred in doing his duty.

The real test of person lies in how he suspend to adversity, and 'courage' allows him to act in a manner which he find ethical.

Courage lies not in absence of fear but overcoming it. So brave person → must overcome any resistance to practise of ethics in life.

(150 Words) (10 Marks)

Indian Independence Struggle was unique in the sense it had elements of spirituality and ethics in it. The concept of Swadeshi, Bharat Mata, truth and non violence made it truly ethical.

### Ethics help in Sustaining Movement

#### ① Protecting the Character of Movement

Devotion to the principle of non violence allowed the leaders to protect the movement from violence.

e.g. Gandhiji called back Non-Cooperation movement in wake of Chauri-Chaura incident.

#### ② Motivation to revolutionaries

Even in the face of arrest, death sentence values of love towards motherland, courage, loyalty towards

fellow partners allowed the leaders to protect movement and members.  
c.g. Despite setback in Ghadr Movement Rashbehari Bose went on to help in establishing INA. ✓

### ③ Compassion towards vulnerable section

The marginalised section like women, dalits were integrated into movement not just to uplift their political status but to transform them socially and economically.

Patriotism in independence was only a part of Indian Independence struggle.  
 The leaders set their eye on larger goal of ensuring liberty, equality, fraternity, unity of the nation.

Not only ethics helped sustaining the struggle but the struggle also developed a more ethical nation post independence.

7. What is wrong in accumulation of wealth? Mention few ethical responsibilities of the 'have' towards 'have not'? (150 Words) (10 Marks)

As per expert institute report around 11% of population controls around 55% of wealth in India.

The accumulation of wealth in hands of few is in stark contrast with about 27% who live below in absolute poverty.

Ethical concerns due to accumulation of wealth

- ① Rising inequalities makes it impossible to distribution of resources in economic wealth difficult.
- ② More power to few in comparison to majority.
- ③ May lead to creation of social hierarchy.
- ④ Due to lesser bargaining power the vulnerability of weaker section is enhanced.

Remarks

'wealth' per se is not wrong, every person aspire to acquire wealth. The accumulation wealth also gives rise to good qualities like sense of achievement, motivation to work hard, philanthropy etc.

However, the have have few ethical responsibilities towards have not like

- ① Treating have nots with dignity.
- ② Helping the have nots within their capacity.
- ③ Ensuring that 'have nots' have opportunity to come out of poverty. → trusteeship, super tax

Gandhi's Sarvodaya model is a true guiding light in this direction. The wealth accumulated must be utilised in such a manner that it leads to welfare of society.

8. "Intellectual Property Rights should be rights with reasonable restrictions". Comment in the light of utilitarianism.  
(150 Words) (10 Marks)

Intellectual Property Rights are guaranteed to protect the innovation or creation of a person. It ensures that benefit arising out of such innovation are available to the original creator.

Eg. Patent, trademark, copy rights.

While the IPR protect individual rights, the utilitarian principle envisions "maximum happiness of maximum number". At times both are at conflict.

Eg. The injection to treat spinal muscular atrophy (SMA) costs around £16 crore, while the patent on technology ensure benefits to producer it restrict the right of life to many.

Remarks

Absolute rights generally create restrictions on others like any other right IPR must also be reasonably restricted.

e.g. compulsory licensing provisions has been accepted under Doha Declaration by WTO in case of emergency.

Utilitarianism at its extreme may discourage innovation if it removes IPR. Thus IPR with reasonable restriction creates a golden mean between two extremes.

9. In what ways ethics has influenced the Preamble of Indian Constitution?  
(150 Words) (10 Marks)

Preamble of India reflects the mind of the constitution makers. It encompasses the values which are present in the constitution e.g. Secularism, liberty, equality, justice.

Different ethical values can be traced in preamble like

- ① Human dignity, it finds its place in the principle of justice i.e. Social, economic and political
- ② Compassion and care are found in the principle of equality in the preamble.
- ③ Tolerance, towards various religion is reflected with Secularism.
- ④ Egalitarian society is envisaged

through the adoption of Socialist principle.

- ⑤ Brotherhood, through the principle of unity and fraternity.
- ⑥ Freedom, by the means of principle of justice.

Preamble reflects the aims and aspirations that 'we the people' carry with respect to our constitution. It represents the ethics we expect in the functioning of our democratic republic.

Preamble thus, is not a mere statement of values rather it's a gist of the ethics that are inscribed within the Constitution.

10. Describe what is ethics? "Both morality and ethics loosely have to do with distinguishing the difference between good and bad or right and wrong". In the light of above statement differentiate between ethics and morality? (150 Words) (10 Marks)

Ethics is derived from the ~~the~~ Greek term 'ethos' that means habit or custom. Ethics are series of principle that are provided by external agency to determine 'wrong' or 'right' examples.

Morality on the other hand is concerned with individual principle that guide behaviour.

### Ethics

- ✓ Determined by external agency
- ✓ largely consistent and static
- ✓ followed due to peer or social pressure.

### Morality

- ✓ Individual beliefs and principle
- ✓ May change if individual changes his/her beliefs or value.
- ✓ followed to ensure consistency in behaviour.

Remarks

e.g. when a lawyer knows that the client he is supposed to defend is guilty, his morals may promote him to leave the case, but his ethics tells him that every accused has right to be defended

Morals thus ensure the consonance of individual actions with his values and beliefs, and ethics ensures consonance in accordance with values and principle dear to the society.

Both ethics and morality thus helps us in finding the true good!

e.g. while social evils like 'Sati' were not against ethics at a time but morality of individuals like Raja Ram Mohan Roy guided ethics towards true good.

Similarly, while <sup>morals</sup> ~~ethics~~ of a criminal may be different from ethics, ethics in this case helps in finding "good".

11. What are ethical dilemmas? Utilitarianism is considered to be one of the ways to solve ethical dilemma. How? (150 Words) (10 Marks)

Ethical dilemmas are situation when there are competing <sup>values</sup> ethical at stake. choosing one over other compromises the other. There <sup>is</sup> no choice that is completely right and no choice that is completely wrong.

e.g. while allocating budget to social services, the concern of all vulnerable sections are genuine but a decision needs to be made as budgetary allocation is limited.

Utilitarian philosophy prescribes the 'Greatest happiness of greatest number' as the golden rule to resolve ethical dilemma.

e.g. wealth tax is justified from utilitarian perspective as it ensures greatest number of people as happy.

Remarks

against the cost of very few.

While utilitarian approach is a vital perspective it may not be able to resolve ~~all~~ <sup>all</sup> dilemmas like -

(a) When life and liberty are at stake.

(b) When majoritarian demand curtails basic rights of marginalised section e.g. dowry

Other approaches to deal with either dilemma can be utilized in such case

e.g. (1) Justice approach

(2) Rights approach

(3) Virtue approach

(4) Humanitarian approach

Ethical dilemma present complex choices that are required to be properly evaluated before any decision is made.

12. "When people choose a political life, they ought to have to follow an ethic distinct from private morality. Though political, public and private morality is related but not identical. They may come from the same source, but are distinct". Examine.

(150 Words) (10 Marks)

Morality helps in determining right or wrong, good or bad in every walk of life. Depending upon which aspect of human life it affects morality can be classified as -

- (a) Private morality & concerning the private relations and conducts  
eg love and care to family
- (b) Public morality & concerning public life eg objectivity, impartiality.
- (c) Political morality & concerning activities like electoral politics, international relation etc

The classification may differ but the essence remains same i.e. to be good.

Public, political and private morality are identical in following ways -

Remarks

- (a) Source - derived from the experiences, beliefs, values that are common like religious, social, constitutional
- (b) Nature - similar values are reflecting in all e.g. Honesty, Truth, Compassion.
- (c) Scope - all are concerned with human action and human relations.

### Distinct nature

Morality of public life differ ~~is important~~ <sup>Why it</sup> the people in from private morality in a manner that while private morality is checked and guided by individual conscience, public morality is embedded in society, etc.

Political morality also differ ~~at~~ at times because means like deceit are utilized to secure larger interest.

The ~~coherence~~ <sup>maximum</sup> is all however is required to develop a ethical society. As a person who is immoral in personal life cannot be expected <sup>to be moral in</sup> public life and vice-versa.

Recently, the bill to extend the period for termination of pregnancy from 20 weeks to 24 weeks was introduced in Parliament.

Abortion presents following ethical issue:

- (b) Right to dignified life for a fetus with abnormalities
- (c) Women's right over her body.
- (d) Can fetus be recognised as a life?
- (e) Religious banetion against abortion

women empowerment means ~~making~~<sup>that</sup> women ~~are~~ are in control of their life choice. Their right over their own body is thus implicit in women empowerment.

In the absence of liberal and scientific abortion law, the choice of women is curtailed. The decision on their behalf are taken by others.

This also forces few women to take recourse to illegal and unhygienic facilities threatening their life.

Thus, women right over their body needs to be suitable aligned with right to life of foetus, in order to make abortion law as a tool not hinderance to women empowerment.

India, being a mixed economy, needs government intervention in the area of education because education driven by profit motive cannot benefit the masses. More Indian children are in school than ever before, but the quality of government schools has sunk to spectacularly low levels. The children in these schools come from the poorest of families - those who cannot afford to send away their young to private schools elsewhere. India has had a legacy of weak schooling for its young, even as it has promoted high-quality government-financed universities. In light of the grim picture of public schooling in India, suppose you are a District Collector and a group of poor people approaches to make you aware about the pathetic conditions of public schools in their areas. They handed you a letter that contains five problems regarding the dismal state of schools, i.e., lack of hygienic toilet facility especially for girls as there are common toilets only, non-availability of clean drinking water, lack of proper security, absentee teachers and rude behavior of teachers and staff with the students. Because of such problems, often parents are not sending their children. The dropout rate is also high. Your Education Minister also expects something concrete from you as he has to answer the local public and media about this issue. With respect to such problems, how will you go about providing solutions so that your action may become example for others to learn?

Drug menace has infected the youth of country heavily in last few years. According to AIMS Delhi Study about 15% of youth are addicted to one or other form of drug.

In the above situation, pressure to arrest Ratandeep who is a drug user is there, by the community elders.

### Dilemma involved in the case

- In the above case, the existence of a drug addict is causing inconvenience to the local community, dilemma

in the case is that the person is  
only a addict not a dealer so while  
sympathy arises for him at the same  
time concern of community are also  
valid.

He has also served jail so there is  
a chance that former penal action  
may reduce his chances of getting back  
to the mainstream.

(b) The ethics in this are based on

but humane touch is also needed to  
deal with such sensitive case.

Taking a strict action might serve  
the law in letter but it may not  
be true the spirit of law. A

  - ✓ Continue with the work with existing team with some dedication and make a case for reinstating the officials


